IPRA Form Instructions

- 1)** Enter IPR submission/initiation date with Customer.
- 2)** Enter Contractor/Vendor Name as awarded in STD. 213.
- 3)** Enter Agreement Number from STD 213 "Agreement Number" field (including amendment number if applicable).
- 4)** Enter the full name of the agency/entity receiving the rate reduction.
- 5)** Check if it is a "Standard IPR".
- 6)** Check if it is a "Duration IPR" and enter the term end date.

A Duration IPR shall require the Customer to commit to a mutually agreed term.

Both Standard and Duration IPRs reduced rate will continue to be in effect from the date of the IPRA approval through the remainder of the term of the Contract unless terminated earlier by Customer or CALNET in accordance with the terms and conditions of the Contract identified above.

- 7)** Enter a brief and concise description of the services receiving the price reduction (e.g., "5.2.4.1 Internet Flat Rate Service (InFRa)", "3.2.1.6.b Unsolicited MAE Services and Features", etc.).

NOTE: The IPRA cannot modify any terms or conditions of the Contract identified in number 3. Commitments here in shall not exceed the Contract term.

- 8)** Enter Category or Subcategory and Section number from Contract Catalog. (e.g., 5.2.4.1, 3.2.1.6.b, etc.). Contractors may add additional tables for additional categories if the categories are within the same Contract.
- 9)** Identify and list products being discounted as noted.

NOTE: Rows can be added to or subtracted from this field, as appropriate.

- 10)** Enter the full address (street, city, state, state and zip) of the location(s) where the IPRA applies.

- 11)** Enter the official Contractor/Vendor name, forward to agency/entity signature authority to complete their name, title, date, and sign.
- 12)** Enter the entity/agency Customer name, forward to Customer to complete print name, title, date, and sign.
- 13)** Contractor shall route the IPRA for signature to authorized Customer and Contractor representatives.
- 14)** Forward the completed signed IPRA to CALNETsupport@state.ca.gov
